#### 1. To receive apologies for absence.

Cllr D Morgan declared an interest in Young @ Hearts, Greater Bargoed Partnership, Tarragan and Gilfach Community Centre.

#### 3. Police Report

Inspector Muirhead gave the following report -

The Christmas period passed with no significant incidents, however a slight increase in violent crime within the Town.

Cllr V Stephens made the Inspector aware of the issue concerning 'pint glasses' being placed under parked cars at Cross Street and gangs of youths congregating within the area.

Cllr S Davies asked for clarification when reporting illegal parking. The Inspector confirmed that dealing with parking is an issue due to cars moving on prior to police attending the scene. The Inspector suggested emailing Serg. Manchino, with all illegal parking concerns. Cllr DT Davies will email the Inspector with 'hotspots' that continue to attract illegal parking, including disabled parking and restricted parking areas.

Cllr DT Davies informed the Inspector of ongoing issues with 'illegal' Taxis. The Inspector to work with trading standards and licensing on this matter.

The Clerk made the Inspector aware of a letter received from a local resident concerning ASB. **RESOLVED:** Clerk to email details to the Inspector and Sergeant.
