Disgwylir y bydd y gwaith wedi'i gwblhau o fewn 6 wythnos, fodd bynnag, efallai y bydd tywydd garw yn amharu ar yr amserlen hon.

Bydd llwybr arall ar gael ar hyd yr A469, Farm Road, Fochriw Road, Pontlottyn Road, Brook Row, Ogilvie Terrace, Bailey Street a New Road ac i'r gwrthwyneb.

Ni fydd mynediad ar gael i'r gwasanaethau brys yn ystod y cau oherwydd gwaith adeiladu'r ffordd. Bydd mynediad ar gael i gerddwyr lle bo hynny'n bosibl. Bydd y gwyrriad i gerddwyr ar hyd llwybr beicio Cwm Darran, a elwir hefyd yn Bristol Terrace.

Y rheswm dros wneud y Gorchymyn yw caniatáu gwaith draenio brys.

Temporary Prohibition of Driving
Order 2021**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Unnamed road between Groes-faen Terrace and Factory Road, Groesfaen, Bargod.

The proposed Order is expected to commence on Monday 11th October 2021 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed within 6 weeks, however, inclement weather may affect this timescale.

An alternative route will be available via A469, Farm Road, Fochriw Road, Pontlottyn Road, Brook Row, Ogilvie Terrace, Bailey Street and New Road and vice versa.

No access for emergency services will be possible during the closures due to the road construction. Pedestrians access will be maintained where practicable. The pedestrian diversion route will be along the Darran Valley Cycle route also known as Bristol Terrace.

The reason for making the Order is to allow for urgent drainage works.

The Order is required by Caerphilly County Borough Council.
