(Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 (Amendment Order No 6) 2021

NOTICE is hereby given that Caerphilly County Borough Council in exercise of their powers under the Road Traffic Regulation Act 1984 and all other enabling powers and after consulting with the Chief Officer of Police have made an Order the effect of which is:-

Prohibit waiting at any time in order, to improve safety, reduce congestion and aid public transport on the following lengths of road within the Aberbargoed, Bargod and Hengoed Wards

- Bedwellty Road and Neuaddwen Street, Aberbargoed
- School Street/Heol Ysgol Newydd, Aberbargoed
- Under Cardiff Road, Bargod
- Francis Street, Bargod
- Western Drive at junction with lane to rear of Hillside Park, Bargod
- Park Road, Hengoed
- Valley View, Cefn Hengoed

The Order shall come into operation on 5th October 2021.

If you wish to question the validity of the Order or of any of the provisions in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 on the grounds that any requirement of that Act made under it has not been complied with in relation to the Order you may within six weeks of the date hereof apply to the Court for this purpose.
