**Hanbury Road/High Street, Bargoed
Temporary Prohibition of Driving
Order 2022**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Hanbury Road and High Street from its junctions with Hanbury Square and High Street, Bargoed.

The proposed Order is, expected to commence on 7th, 14th and 21st August 2022 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is, anticipated the works will be, completed by 21 August 2022.

Emergency service and pedestrian access will be maintained.

Alternative routes are via Greenfield Street, West Street, Hanbury Square, Angel Way, Station Road.

The reason for making the Order is to allow for maintenance works.

The Order is, required by: Caerphilly County Borough Council.
