Cardiff Road o’r gyffordd â Park Place a Hillside Park am bellter o tua 140 metr.

Disgwylir i’r Gorchymyn arfaethedig gychwyn ar 2 Ebrill 2024 am gyfnod nid yn fwy na deunaw mis neu nes bod y gwaith wedi ei gwblhau, p’un bynnag sydd gynharaf. Disgwylir i’r gwaith gael ei gwblhau erbyn 3 Mai 2024.

TEMPORARY PROHIBITION OF DRIVING ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Heolddu Road from its junction with Upper High Street and North Road for a distance of approx. 105 metres

Cardiff Road from its junction with Park Place and Hillside Park for a distance of approx. 140 metres.

The proposed Order is expected to commence on 2 April 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 3 May 2024.

Access for emergency services and residents will not be maintained. Pedestrian access will be maintained where possible.

Alternative routes are:

Road Closure	Diversion Route
Heolddu Road, Bargoed	Via North Road, Church Street, Church Place.
Cardiff Road, Bargoed	Via Park Drive, Western Drive, St Mary Street, Cross Street.

The reason for making the Order is to allow for gas mains replacement.

The order is required by Wales & West Utilities.
