The Clerk requests details of planned working group activity along with requests to be made to Full Council Members in support of Annual Report completion.

9. To explore the possibility of Bargoed Town Council creating a community awards scheme and holding an annual awards event. Members are encouraged to debate the opportunities, risks, engagement benefits and costs of the project prior to making recommendations to Full Council.
